**Position:** Extension Specialist, Agricultural Economics, Instructor.

The Department of Agricultural Economics at Kansas State University seeks to fill an extension specialist position based at the Southwest Research and Extension Center. The position carries a 100% extension appointment.

The Department has a reputation for excellence in all three functions of the University's land grant mission (teaching, research, and extension). The successful candidate is expected to be an active contributor to the Department's extension and research programs. The Department offers B.S. degrees in agricultural economics and agribusiness, M.S. degrees in agricultural economics and agribusiness, a Master of Agribusiness (MAB) degree, and a Ph.D. in economics with a specialization in agricultural economics.

Southwest Kansas is characterized by intense agricultural production and the importance of managing the finite water supply available from the Ogallala Aquifer which is the economic engine of Kansas agriculture. Nine of the 10 top agricultural producing counties in the state are located in southwest Kansas. Irrigated and dryland crops are key to the beef industry and the expanding swine and dairy operations in the region. Thus, this position is important to the producers, citizens, and other stakeholders in the area as well as the researchers at the Southwest Research and Extension center.

Areas of Extension and applied research emphasis may include, but are not limited to farm management, agricultural finance, production economics, or agricultural marketing. Specifically, the areas of emphasis of this position will include the economics of cropping systems including such items as the economics of water use and bioenergy, the interaction of agricultural and environmental policy with firm decision-making, and the profitability and risk associated with crop and tillage selection in western Kansas under both irrigated and dryland production systems. The Extension education program may also include related crop production topics such as equitable cropland rental agreements, and farm program issues. Duties could also include some work with the economics of livestock production, pasture leasing, and related livestock production issues. The specialist will cooperate with Extension agents and state/area specialists in the Department of Agricultural Economics and various other departments in the Kansas State University College of Agriculture, and communicate Extension and applied research results and needs appropriately. The specialist will cooperate with other specialists and research faculty to provide applied economic analysis of agricultural practices being investigated at the Western Kansas Agricultural Research Centers. The specialist will be expected to provide current, relevant, research-based information to the agricultural clientele of Kansas through public meetings, bulletins, field day reports, press releases, newsletters, individual consultations, and electronic media.

The KSU Department of Agricultural Economics is known for Extension and applied research programs that address real-world problems in local, state, national, and global agriculture and agribusiness.
