Spring Commencement 2021

After not having any commencement ceremonies last year, we were excited to be able to celebrate our graduates in May! All together, the Agricultural Economics Department graduated 90 students during the spring.

The department was also pleased that Ag Econ Ph.D. candidate, Hannah Shear, was selected to be the Graduate School Commencement speaker.

"I was approached by Vice Provost/Dean Claudia Petrescu, and asked if I would consider serving as the Graduate School's commencement speaker. She said that as a 'new' arrival on campus she had asked around and she had heard my name from several people in regards to being an active and engaged graduate student on campus," Shear said. "I was honored to be asked to speak, but was also unsure if I could manage to say anything meaningful or memorable.

"After the past year-and-a-half, many of the graduate students had spent a large portion of their studies in a less than ideal situation. Some students had lost loved ones, jobs, had technology struggles, and more. So I wanted to be sure to recognize that, but I didn't want the speech to be centered around the pandemic. So I chose to encourage our graduates to have grace over success.

"In a combined graduation (Spring 2020, Fall 2020 and Spring 2021) there were more than 700 graduates, so I kept it short, and hopefully sweet," she said.

Here's the speech she shared with graduates:

Grace Over Success

Congratulations. You did it! You have successfully achieved a graduate degree. You have achieved a level of education that a very small percentage of the world population reaches. You have succeeded in your academic endeavors and you deserve to be recognized for all of your hard work. That hard work may have felt insurmountable given all that has happened over the course of the past year. But you persevered. You succeeded.

Success is generally defined as "the accomplishment of an aim or purpose". For each of you, your short-term aim was to achieve a graduate degree. Thus, as a participant in this graduation, you are, by definition, a

success. As you each move forward you will define for yourself a new aim or purpose. I know you will take the knowledge you have gained in your time here at Kansas State University and leverage it to be successful yet again.

So you can call yourself resilient, persistent, and successful as a graduate of Kansas State University. But I want to encourage you, as you leave this place, to consider placing grace before success.

Grace can be defined as "courteous goodwill". I implore you all, as members of the K-State family to always put grace before success. Be gracious in your words, actions, deeds, and choices. Pick up the piece of litter on the ground, return the shopping cart to the stall, comfort someone in need, nominate someone for an award, celebrate another's achievement, send a note to a loved one, be free with forgiveness and stingy with anger. Be harder on yourself and easier on others. Respect one another and our differences, hold the elevator, volunteer, beautify your surroundings.

If you make your aim or purpose to do all things with grace, then you will without a doubt be successful. So as you leave here today to celebrate, go with pride, go with the knowledge that you are forever a part of the K-State family, and go with grace.

K-State Team Wins IFAMA World Student Case Study Championship

K-State's Graduate Students of Agricultural Economics (GSAE) Case Study Team of John Green, Lauren Benavidez, and Megan Hill recently competed in the International Food and Agribusiness Management Association (IFAMA) Student Case Competition. The team was awarded 1st Place in the Graduate Division out of a field of 26 teams from around the world.

"It was a very fulfilling experience having real-life company issues to solve strategically with the knowledge acquired from our master's program studies," Benavidez said. "The group dynamic was great as everyone came up with ideas from our diverse backgrounds and that made the contest also an enjoyable experience."


IFAMA conducts the competition at its annual conference, but due to COVID, the 2021 contest was conducted virtually. During the competition, teams review a selected company and provide recommendations to a panel of senior management judges.

"The IFAMA Student Case Study Competition was held virtually this year and consisted of two rounds. In the preliminary round, we had 24 hours to read and analyze a case study over the company Perfect Day and write a five-page report giving our recommendations to the company," Hill said. "In the final round, we had four hours to read part two of the case study and create a presentation with our recommended solutions. Immediately after the four hours ended, we gave our presentation to the judges over Zoom. This was a challenging experience because of the time constraints, but it gave us the opportunity to use the skills we

learned in the classroom and apply them to real issues that companies face."

The team wins a cash award; opportunities for internships and interviews with the sponsoring companies; an opportunity to serve on a sustainability council for Perfect Day--the company featured in the case study; and complimentary conference attendance for the IFAMA in-person conference in Costa Rica in 2022.

"John, Lauren, and Megan worked hard and were determined to successfully represent KSU in this international competition," Dr. Aleksan Shanoyan, Associate Professor and the team's faculty advisor, said. "Taking 1st place in this global competition indicates the quality of our graduate students and the world-class agribusiness education they receive in the Department of Agricultural Economics at KSU. This continues the tradition of our students placing top in national and international competitions"

Business in Olathe, Kansas as a Management Associate. Her career interests lie in pricing, merchandising, and strategic marketing. She plans to pursue a Masters of Agribusiness after several years in industry and eventually transition into running her own business and operating the family-farm.

K-State Alumni Association Awards

Each year the Alumni Association recognizes students annually with Anderson Senior Awards and Graduate Student Awards.

Faculty and peers nominate students for the awards, and committees consisting of members of the Alumni Association board of directors and K-State students select the recipients.

“These students are role models for leadership, community service, inspiration and academics and exemplify the caliber of students at K-State,” said Tamie Redding, assistant director of student programs for the Alumni Association. “The Alumni Association is pleased to celebrate these students by recognizing them for their contributions to the Wildcat community.”

The Anderson Senior Award recognizes four graduating seniors for excellence academics, leadership, inspiration and service. The award was established in 1998 and pays tribute to K-State’s second president, John Anderson, who served from 1873 to 1879. Of the eight Anderson Awards, two were awarded to Agricultural Economics students.
